Aboriginal Curatorial Collective Alliance Membership Agreement

I understand that membership in the Aboriginal Curatorial Collective / Collectif des Conservateurs Autochtones (ACC/CCA) is open to new and established Aboriginal curators and arts professionals. Aboriginal is hereby defined as Indian, Inuit and Métis peoples of Canada as recognized in the Canadian Charter of Rights and Freedoms, and international indigenous peoples as defined in the ACC/CCA bylaws. The ACC/CCA supports, promotes and advocates on behalf of the work of Aboriginal art and cultural curators and associated Aboriginal cultural workers in Canada and internationally.

The ACC/CCA bylaws also provide that non-Aboriginal arts professionals can hold ACC/CCA alliance memberships that do not have the ability to vote and are not eligible for election to the Board of Directors.

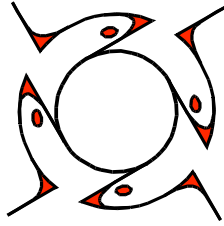
By applying for alliance membership in the ACC/CCA, I agree to the following:

Definition of Aboriginal

from the ACC/CCA Bylaws Draft, October 2005

"Aboriginal" means individuals who are included as Aboriginal Peoples in s.35 of the Canadian Constitution Act, 1982; and

"Aboriginal" will also include international indigenous peoples as described in the following working definition:

Cultural groups (and their descendants) who have an historical continuity or association with a given region, or parts of a region, and who formerly or currently inhabit the region either:

- * before its subsequent colonization or annexation; or
 - * alongside other cultural groups during the formation of a nation-state; or
 - * independently or largely isolated from the influence of the claimed governance by a nation-state; and who
- * have maintained at least in part their distinct linguistic, cultural and social / organizational characteristics, and in doing so remain differentiated in some degree from the surrounding populations and dominant culture of the nation-state; and who are
- * peoples who are self-identified as indigenous, and those recognised as such by other groups.
